**PLEASE NOTE:** Rule 41 (c) iii requires that " If a member is nominated for more than one office on the same Conference, Executive, Council or other body within the Union, such member must, **within seven days (7) after the close of nominations**, advise the Returning Officer in writing which one of such positions the member wishes to stand for, and withdraw any nomination or nominations for the other offices for which the said member was nominated, **failing which, the returning officer shall reject all the nominations for offices** referred to in this sub- rule for that member.
