#### **Lodging Nominations**

Nominations open on 6 March 2019 and must reach the Returning Officer, Noopur Madan **not later** than 12:00pm (Noon) (AEDT) on 27 March 2019.

#### **Withdrawing Nominations**

Nominations cannot be withdrawn after 12:00pm (Noon) (AEDT) on 03/04/2019.

**PLEASE NOTE**: Rule 41 (c) iii requires that "If a member is nominated for more than one office on the same Conference, Executive, Council or other body within the Union, such member must, within seven days (7) after the close of nominations, advise the Returning Officer in writing which one of such positions the member wishes to stand for, and withdraw any nomination or nominations for the other offices for which the said member was nominated, failing which, the returning officer shall reject all the nominations for offices referred to in this sub-rule for that member.
