PLEASE NOTE: As per Union Rules 41c.iii. If a member is nominated for more than one office on the same Conference, Executive, Council or other body within the Union, or is nominated for the office of Member or Alternative Member, or form more than one Office of Alternative Member of the same Conference, Executive, Council or other body, such member must, **within seven days** (7) **after the close of nominations**, advise the Returning Officer in writing which one of such offices the member wishes to stand for, and withdraw any nomination or nominations for the other offices for which the said member was nominated, **failing which, the returning officer shall reject all the nominations for offices** referred to in this sub-rule for that member.

Prospective candidates and nominators should verify their financial status and any other qualifications required by the Organisation's rules prior to lodging nominations.
