s.159—Alteration of other rules of organisation

Alteration of other rules of organisation.

[1] On 14 December 2018 the Australian Municipal, Administrative, Clerical and Services Union (the Union) lodged with the Fair Work Commission a notice and declaration setting out particulars of alterations to its rules.

[2] The particulars set out alterations to Division Three, Queensland (Services and Northern Administrative) Branch Rules:

- 7 – Branch Executive
- 18 – Branch Council Membership
- 33 – Election of Branch Office/Position Holders

[3] On the information contained in the notice, I am satisfied the alterations have been made under the rules of the organisation.

[4] Each alteration seeks to remedy minor inconsistencies which impact the conduct of elections in the Branch.

[5] The alteration to Rule 7 rephrases the number of Branch Industry Division Vice-President positions to ensure consistency with the formula set out in Rule 44.

[6] The alteration to Rule 18 removes table headings that confuse the formula for calculating the number of available Branch Council positions.

[7] The alterations to Rule 33 correct an error so that National Conference Delegates are elected by an electoral college system as is specified in Rule 23.

[8] In my opinion, the alterations comply with and are not contrary to the *Fair Work (Registered Organisations) Act 2009*, the *Fair Work Act 2009*, modern awards and enterprise agreements, and are not otherwise contrary to law. I certify accordingly under subsection 159(1) of the *Fair Work (Registered Organisations) Act 2009*.


