2.2 Business Arising from the Minutes of the National Conference Meeting 21-23 November 2018

3.0 Conference Motions

3.1 The Uluru Statement from the Heart – Voice, Treaty, Truth – Western Australian Branch

The following motion was referred to National Conference by the Western Australian Branch to adopt the following motion into union policy.

Recommendation:

"Makarrata- Coming together after a struggle

The ASU recognises the prodigious history leading to the dialogues of Aboriginal and Torres Strait Islander people coming together and signing the Uluru Statement from the Heart, in 2017. This resolution of ASU National Conference 2022 is tied to the Uluru Statement.

The Uluru Statement from the Heart - Voice, Treaty, Truth

Aboriginal and Torres Strait Islander people seek recognition in the Australian constitution. Such constitutional reform must be more than symbolic.

Recognition should also enshrine substantive, structural reforms that are endorsed by Aboriginal and Torres Strait Islander communities. The principal reforms presented in the Uluru Statement, are the recognition of Aboriginal and Torres Strait Islander people as the First Nations of this land ('the Truth'), a Treaty linked to that sovereignty and a protected Voice to the Australian Parliament.

47th Parliament of Australia

The Albanese government, led by Prime Minister Anthony Albanese of the Australian Labor Party, made holding a referendum on an indigenous voice to parliament during his first term, an election promise in 2022.

National Conference, therefore, commits to supporting First Nations people and the constitutional reforms presented in The Uluru Statement from the Heart of 2017, calling on Australians to enshrine Voice, Treaty, Truth in the Australian Constitution."

3.2 Local Government Financial Sustainability – NSW Local Government, Clerical, Administrative, Energy, Airlines and Utilities Branch

The following motion was referred to National Conference by the NSW Local Government, Clerical, Administrative, Energy, Airlines and Utilities Branch to adopt the following motion into union policy.

Recommendation:

"The ASU recognises local governments are an important part of our community. They provide the services that we, as citizens, rely heavily on: waste management, roads maintenance, and the provision of local libraries and public swimming pools to name a few.

The ASU recognises the financial sustainability of local governments across Australia continues to be a challenge and has been undermined by Commonwealth funding arrangements that are no longer fit for purpose.

In recent times the COVID-19 pandemic has presented challenges to local government on a scale not seen before and has further exacerbated the sustainability challenges already faced by the sector. The diversity of the sector means that no single solution or approach will address the sustainability challenges faced by many local governments.

National Conference therefore commits to lobbying the federal government to implement the following measures aimed at improving the financial sustainability of local government:

- Australian government Financial Assistance Grants (FAGs) to Local Government should be set to at least 1% of aggregate Commonwealth tax revenue.
- Reform the Local Government financial system to ensure no councils are financially disadvantaged.
- End cost shifting Government must offer funding and grants to keep pace with delivery costs.
- A federally funded trainee and apprenticeship scheme should be launched centred on Local Government.
- The establishment of a Fair Jobs Code to stop the exploitative use of labour hire, lift standards and to protect the rights of all local government workers.
- Amendments to National Disaster Funding should be made to channel additional funding through Local Government and ensure financial assistance is expended in affected local communities and work performed by locally employed council workers.
- Inclusion of Local Government as a permanent member of National Cabinet
- Rate capping should be abandoned as a matter of priority.
- The Regional Employment Development Scheme (the RED scheme) should be reintroduced. This could be provided at a reasonable cost with the Federal Government providing a base pay equivalent to current safety net payments and council's topping up those payments to the rates of pay applicable in that particular workplace having regard to Award, Enterprise, and Salary System rates of pay in the relevant State or Territory.
- Ensure a national Energy Transition Authority is federally funded and established.

Financial sustainability will allow local governments to provide the goods and services they promise, in an efficient and sustainable manner: because no one can afford for councils to fail due to financial difficulties.



3.2 UN Treaty on the Prohibition of Nuclear Weapons

The following motion was referred to National Conference by the VICTORIAN PRIVATE SECTOR BRANCH and referred to National Conference to adopt the following motion into union policy.

Resolution:

"That the 2018 ASU National Conference endorses the following recommendation:

The Australian Services Union welcomes the adoption of the UN Treaty on the Prohibition of Nuclear Weapons (TPNW) in 2017. This treaty is the first agreement to comprehensively prohibit nuclear weapons, placing them in the same legal category as antipersonnel mines, cluster munitions, chemical and biological weapons.

ASU National Conference shares with ICAN deep concerns about the catastrophic humanitarian consequences that would result from any use of nuclear weapons. We recognise the urgent need to rid the world of these abhorrent and immoral weapons.

Australia joining the TPNW is an essential step on the path towards the total elimination of nuclear weapons. The Australian Services Union calls on the Australian Government to sign and ratify the treaty as a humanitarian imperative."

3.1 Future of Works – QLD Together Branch

The following motion was referred to National Conference by the QUEENSLAND TOGETHER BRANCH and referred to National Conference to adopt the following motion into union policy.

Resolution:

"That the 2018 ASU National Conference endorses the following recommendation:

The ASU recognises that the nature of work will change radically within the next thirty years as a consequence of advancements in digital technology, artificial intelligence and robotics.

The ASU recognises that the nature and timing of these changes cannot be accurately forecast at this stage, however the ASU also recognises that the adopting of and adapting to new technologies can provide better jobs and better services to the community.

Engaging with staff on the possible future of work at employer level will provide workers a better opportunity to influence and improve how such technologies are implemented. It is recognised that consultative forums can consider opportunities proposed by employees.

The ASU acknowledges that the consultation on the future of work does not currently fall appropriately within the specific industrial requirements for consultation on organisational change until a specific proposal is developed by the employer for introduction. New consultative mechanisms and requirements should be sought for inclusion within our awards and collective agreements. The nature of job design and structure would be impacted by the introduction of new technologies and should be considered as part of any proposals.

The ASU recognises the importance of employment security for employees is a vital pre-condition of consideration and consultation around the introduction of digital technology, artificial intelligence and robotics.

The ASU notes that the introduction of new technologies is changing the nature of work and when and where work occurs. We are supportive of appropriate flexible work practices which improve members working lives and provide a better work life balance, but inappropriate use of the new technologies can lead to work intensification and a worse work life balance.

The ASU will commit to develop appropriate industrial regulation and systems in awards and collective agreements to provide appropriate compensation for the extension of work outside of the currently recognised work hours.

The ASU will develop appropriate limitations on the use of new technologies in awards and collective agreements to protect members work life balance."
