DECLARATION OF AUTHORISED OFFICER in accordance with Regulation 126 Fair Work (Registered Organisations) Regulations 2009

ALTERATION OF OTHER RULES OF ORGANISATIONS in accordance with section 159 of the Fair Work (Registered Organisations) Act 2009)

I, EMELINE GASKE, the Assistant National Secretary of the Australian Municipal, Administrative, Clerical and Services Union (**ASU**) declare:

- 1) The ASU has made application to the Fair Work Commission in matters:

(together the Matters)

- 2) As at the date of the further application to amend the rules of the ASU, the subject of this declaration (**Application**), the FWC has not made a determination in relation to the Matters.
- 3) I am authorised under the rules of the ASU (Rule 42A) to give this notice of particulars of further amendments to the alterations to the rules of the ASU and to make this declaration under Regulation 126 of the Fair Work (Registered Organisations) Regulations 2009 (Cth).
- 4) The proposed further amendments the subject of the Application are inter alia in relation to, apply to and affect the Matters and the Application must be determined in the context of the Matters.
- 5) The action taken under the ASU Rules to make the Application is set out below.
- 6) Rules 8 cb. and j. and 49 a. and b. relevantly provide for rule alterations:

8 - NATIONAL EXECUTIVE

- cb. Each Branch National Executive Representative shall exercise equal proportions of the Branch votes in accordance with the number of National Conferences

 Delegates to which that Branch National Executive Representatives' Branch is entitled in accordance with Rule.
 - j. The National Secretary may, and shall when so requested in writing by National Executive representatives carrying at least one third of the votes of the branches on National Executive, submit a motion or question by letter or telegram or facsimile or electronic mail to each member of the National Executive. Upon a majority vote being received by letter or telegram or facsimile or electronic mail, (with members exercising votes in the manner provided in sub-rule c. hereof) the decision so obtained upon such motion or question shall have the same effect as a decision made by resolution of the National Executive passed at a duly constituted meeting;

Provided that, if within a period of twenty-one days from the dispatch of the letter or telegram or facsimile or electronic mail, the motion has not been determined in accordance with the foregoing provisions the motion shall be determined in accordance with the majority of opinions expressed (with members exercising votes in the manner provided in sub-rule c. hereof) and shall thereupon become a resolution of the National Executive as though it had been passed at a duly constituted meeting if the number of votes cast be not less than half of the eligible votes of the National Executive

49 - RULE ALTERATIONS

- a. The Rules may be added to, changed, amended, varied, repealed and/or deleted by a resolution of the National Conference or a resolution of the National Executive carried by a majority of votes cast in accordance with Rules 7 and 8 respectively.
- b. Any proposed addition to, change, amendment, variation, repeal and/or deletion of the rules shall be submitted by a Branch Committee of Management or a member of the National Executive to the National Secretary or be proposed by the National Secretary for submission to National Conference or the National Executive in accordance with Rules 7 and 8 respectively, provided that Rules 6, 7, 8, 9, 10, 14, 16, 21, 46, 47 and 49 shall not be altered unless seventy percent of the votes entitled to be cast are cast in favour, and provided further a Branch Rule shall not be added to, changed, amended, varied, repealed and/or deleted, without the consent of the Committee of Management of the Branch or the Branch Council of the Branch where the Branch Rules so provide.
- 7) I am the acting National Secretary, being the Assistant National Secretary temporarily acting under the rules as the National Secretary in the temporary absence of the National Secretary.
- 8) On 16 December 2022 I proposed to the National Executive, under National sub-rule 49 b.:
 - a) amendment to the National and Branch rules in the Matters; and
 - b) addition to, change, amendment, variation, repeal and/or deletion of the National and Branch rules of the ASU.

(together the **Proposed Further Rule Amendments**).

- 9) The Proposed Further Rule Amendments were submitted to the National Executive, consistently with the provisions of rule 8 j., by email.
- 10) The materials submitted by email were:
 - a) explanatory correspondence from me in relation to how a vote was to be cast in the ballot (Explanatory Correspondence);

 - d) attachment 'EG3' being the copies of correspondence received from each of the Branches, the subject of the Proposed Further Rule Amendments, confirming that the respective Branch had consented to the Proposed Further Rule Amendments in so far as the Proposed Further Rule Amendments affected the Branch.
- 11) I annexe as 'EG1' the Explanatory Correspondence.

- 12) I annexe as 'EG2' the preamble to resolution A and resolution A.
- 13) I annexe as 'EG3' being a bundle of correspondence from Branches.
- 14) Each member of the National Executive was forwarded, and received, a copy of the materials set out in clause 10.
- 15) The ballot opened on 16 December 2022.

- 19) The majority required by rule 49 a., has been met.

 - iii) Transport and Northern Administrative Branch Industry Division employed in rail; and
 - iv) Transport and Northern Administrative Branch Industry Division employed in the:
 - 1. Ports and Private Sector; or
 - 2. North Queensland Clerical and Administrative Industry Sector.
- f. Despite sub-rule a. if there are, 90 days prior to the opening of nominations for the Quadrennial Elections of the Branch, more than 5000 Financial Members attached to a Branch Industry Division or Branch Industry Division Sector, then the respective Branch Industry Division or Branch Industry Division Sector will be entitled to elect an additional Branch Industry Division Vice-President by, and from, the Financial Members attached to the respective Branch Industry Division or Branch Industry Division Sector.

Eve Anderson of the FWC registry has raised issues with the Branch tables in the proposed national electoral rule amendments.

In relation to the USU Branch Table (rule 84) the issue is over the designation of 1 office required to be elected – see the last row of the table, right hand column.

This is inconsistent with rule National Rule 8 ca. and USU Branch rule 30 (which refers back to the National Rule).

I propose to correct as follows:

a. That proposed rule 84 in application [insert] be amended by, in the last row of the table, deleting the word '1' and inserting in lieu 'see Part II sub-rule 8 ca.'.

This formulation is consistent with a similar change in a number of the other Branches. I do not see there is a need for reference to the Branch rule.

I will be preparing a 'remediation' resolution for the National Executive.

I may require a consent from GK on behalf of the Branch as well, but have not yet made a final determination in that regard.

Can you please confirm with GK that this is an appropriate approach.


