4.0 PROTECTION OF NSW LOCAL GOVERNMENT AWARD RATES OF PAY

Moved: Peter Collins Seconded: Paul Reid

"That the 2010 ASU National Conference endorses the following resolution:

If NSW Local Government is excluded from the modern award system there is a real likelihood that this situation could alter with a change of State and/or Federal Government. The differences in the rates of pay under the Modern local government award 2010 and the NSW Local Government (State) Award are extreme. Where the modern award to be applied in NSW local government take home pay orders along would not be sufficient. Those employees indentified as "red circle" positions (known colloquially in NW Local Government as "present occupants only", or POOs") could well have their rates of pay frozen for years, if not decades.

When and if the red circle/POO does take effect, there would be a significant impact on the living standards of our members.

It's proposed that the ASU conduct a federal lobby for the government to:

"Pass regulations and/or vary the Fair Work Award principles to provide that any employee whose pre-existing state award/NAPSA rate is over and above the equivalent modern award rate will gain access to general award increases under Fair work Award variations."

Employees dependent on federal award rates of pay have already gone for a period of twelve months without access to general wage increases. While the Federal Government and ACTU are supporting a "catch up" increase in this year's Fair Pay Commission order, this absorption issue could well undermine the positive effective of any such order."

Peter Collins, NSW United Services Branch spoke in favour of the motion.

5.0 DOMESTIC VIOLENCE

"The National Conference acknowledges the serious impact of family violence on individuals and communities. The overwhelming impact of victims of family violence are women and children and this experience has a devastating affect on their health and welfare, often into the long term. The impact of family violence is also felt in workplaces and in our broader community.

The national conference believes that the ASU can play an important role in eliminating family violence and has a responsibility to work towards this goal. National Conference therefore commits the union to working towards the goal of eliminating family violence by:

- Showing leadership in advocating for industrial and workplace based initiatives aimed at preventing family violence and/or providing support to victims seeking to escape family violence;
- Advocating for the inclusion of clauses in workplace agreements aimed specifically at eliminating family violence and providing support to those in the workplace experiencing family violence;
- Raising awareness of the issue amongst our members, encouraging ASU members to participate in events and activities aimed at eliminating family violence and providing financial and/or other support as appropriate to such events and activities;
- Building partnerships with other organizations in order to achieve these ends. This will include in the first instance becoming a Project Partner in the Domestic Violence Workplace rights and Entitlement Project with the Australian Domestic and Family Violence Clearinghouse (ADFVC) to build the capacity of our union to implement domestic violence workplace provisions."

Superannuation Panel

Chaired by: Greg McLean, Assistant National Secretary

Speakers: Debbie Blakey, HESTA, David Smith, QLD Services Branch, Scott McNamara, NSW US Branch, Tom O'Neill, AustralianSuper, Gayleen Smith, Selectus Salary Packaging

The panel discussed issues surrounding the effects of the Global Financial Crisis on superannuation funds, repercussions of the Government's Cooper Review and the importance of workers' planning for their retirement. The role of unions through bargaining and lobbying to improve superannuation for members was also explored.

Industrial Relations Panel

Chaired by: Keith Harvey, ASU National Industrial Officer

Speakers: Jo Justo, ASU National Office, Vice President Michael Lawler, Fair Work Australia, Dave Perry, QLD Services Branch, Nicky Lindsay, C&SQ C&A Branch.

Vice President Lawler spoke of the importance of an independent judiciary - including in industrial relations - in applying and interpreting the law as determined by Parliament. His Honour reflected on a number of key issues arising from the new Fair Work Act and answered questions from Conference delegates on a range of issues.

Keith Harvey introduced the fundamentals of the new Fair Work system and Jo Justo spoke about bargaining under the new Act and the essential requirements for successful outcomes for members. Dave Perry spoke about bargaining in local government in Queensland - which is now in the State IR system. Nicky Lindsay spoke of a successful bargaining campaign in the Mater Hospital.

Occupational Health & Safety Panel



Item 3.3:

We acknowledge the role of the National Airlines Division Council (NADC) in coordinating the ASU branches and members in airlines. We believe that the airline industry members would benefit from further rank and file structures to ensure that delegates and members have forums to discuss current airline issues and share information so that we can increase industry awareness and achieve better results for all members. Such forum should include the formation of join consultative committee made up of state based ASU airline and aviation members which we request the National office form and coordinate as soon as practicable.

The Airlines Branch call on the ASU to liaise with both the ACTU and Unions NSW to co-ordinate all unions with coverage in the aviation industry and airport. This would enable our delegates to have a uniform approach to aviation issues."

The Airline Branch supports the efforts of our members bargaining with their employers to maintain our hard fought for wages and conditions. We recognize the cyclical nature of the aviation industry but strongly reject attempts by our employers to use the current global economic crisis to justify ongoing attacks on wages and conditions. To this end to support members fighting to maintain the standards in the aviation industry."

8.0 HESTA SUPERANNUATION BOARD

"That the National Executive endorsed the following and resolved to forward it to National Conference for consideration:

This National Conference notes that there are no employee representatives for SACS workers on the HESTA super board and there are two employer representatives. SACS members now make up approximately one quarter of HESTA's membership; it is unacceptable that SACS workers have no representation on their Super Fund.

This Conference demands that the HESTA Board immediately take steps to resolve this issue to ensure proportional representation and directs the National Secretary to report to the next Executive what if any steps have been taken."

7.0 STOP THE NT INTERVENTION – JOBS WITH JUSTICE FOR ABORIGINAL WORKERS

Moved: Katrine Hildyard Seconded: Kate Davis

"That the 2010 ASU National Conference endorses the following resolution:

1. Income Management:

The ASU opposes compulsory Income Management or any Centrelink program which restricts inalienable rights to social security.

Conference notes that \$105 million was allocated in the 2009/10 federal budget to administer programs or compulsory income management in the Northern Territory. The 'Closing the Gap Monitoring Report NT' released in October stated that \$150.3 million of Centrelink income was 'Income Managed' over this period. Conference condemns the excessive waste of this punitive program where resources are badly needed in these communities for employment and social services.

Conference endorses section 27 of ACTU ATSI policy passed at the 2009 Congress which states:

"Congress calls on the government to work with communities to develop voluntary, agreed programs which support communities in all aspects of social life including financial literacy, parenting and caring responsibilities."

The Social Security and Other Legislation Amendment Act 2010, which passed through the Senate in June has allowed for the expansion of compulsory Income Management across the NT and authorizes the future imposition of compulsory Income Management on communities across Australia. Conference notes the opposition to this legislation from a broad cross section of the community, including the Australian Council of Social Services, the ACTU Indigenous Committee and both the Central and Northern land councils. Conference calls for the repeal of this legislation.

2. CDEP and Aboriginal Employment:

Conference notes the enormous damage to Aboriginal communities and employment in the community sector done by the decision to begin closing down Community Development Employment Projects (CDEPs) across Australia.

Conference condemns the 'reformed' CDEP program which are coercing people in remote communities to work for Centrelink entitlements, 50% of which are 'Income Managed' for workers in the Northern Territory.

Conference calls for massive investment in job creation, with proper salary packages in all Aboriginal communities, to replace the jobs lost through cuts to CDEP.

Conference endorses the statement 'Jobs with Justice' published in the Australian newspaper on July 29 2010 and support by the SA, NT, NSW and ACT branches of the ASU (Appendix 1) and commits to a campaign to advance the demands of the statement.

3. NT Intervention:

Conference notes that the United Nations Committee for the Elimination of Racial Discrimination (UNCERD) ruled in august 2010 that Intervention legislation provides clear evidence of "embedded racism" against Aboriginal people in Australia. The UNCERD report also said living conditions had deteriorated for Aboriginal people under the intervention through loss of land, property, employment, legal rights and opportunities for cultural development.

Conference endorses section 18 of ACTU ATSI policy passed at the 2009 Congress which states:

18 Congress rejects that changes and proposed changes to Aboriginal Land Rights Acts, the elimination of permit systems in Aboriginal communities, and the forced acquisition of Aboriginal title to land, have any relationship to genuine measures to protect children. Congress calls on government to cease its policy of making communities trade their land rights for the provision of essential services which are fundamental rights in all other Australian communities.

Conference condemns the suspension of the Racial Discrimination Act (1975) to implement discriminatory intervention measures. Conference also notes submissions made by a broad range of organisations including the Australian Human Rights commission and Amnesty International which outline how amendments to NTER legislation passed in June still deny Aboriginal communities access the full protections of the RDA.

Conference calls for the repeal of all discriminatory NTER legislation. Addressing the acute social crisis faced by Aboriginal communities in the NT will require the ongoing commitment of significant resources to improve community life. Aboriginal people must be empowered to shape the direction of service delivery and economic development in their communities."

4.0 LIFE MEMBERSHIP – MARY-ANNE O'NEILL



Mary-Anne O'Neill Nominated by: Central & Southern Queensland Clerical & Administrative Branch

Mary-Anne's activism was engaged when as a young woman she listened to a speech in Tumut from a man on the back of a truck that inspired her. This man was Gough Whitlam. Being part of a rural community meant that team work was important, particularly during bushfire season. The loss of the family dairy farm to progress also alerted Mary-Anne at a young age to harsh realities of life.

Mary-Anne worked as a switchboard operator for some years and was recruited into becoming a Delegate for her union at the time. From this early activism, she came to work in the union office. This route eventually led to her running a centre dedicated to health and safety training for workers.

The ASU lured Mary-Anne to Queensland in 1995 where she began working as an Organiser in the private sector. The Branch was made up of 85% female members at this time, and the union was undergoing significant change, moving from a servicing to organising culture. The change in direction presented significant challenges for the union, and Mary-Anne was integral to this process, working with the Leadership of the Australian Services Union C&SQ to build a Branch that focused once again on members.

Over time, Mary-Anne took on the role of the Branch Trainer and the Assistant Branch Secretary.

During these years, she was instrumental in setting up Work Organising committees and recruiting delegates across both the Private Sector and Public sector. She also supported members during the privatisation of Suncorp, Tatts Bet (TAB) and Golden Casket from government owned corporations to private enterprise.





4.0 LIFE MEMBERSHIP – MARY-ANNE O'NEILL

In 2009, Mary-Anne answered the call for further public service, taking up a position in the Bligh Government as the Member for Kallangur. She continued to promote the union and recruit new members, and applied her significant organising skills to working with her new local constituency. During her campaign Mary-Anne told people that her union would have open access to her calendar and that she would do all she could to assist ASU Members if and when she was elected to State Parliament, and she honoured her promise.

One of Mary-Anne's many strengths is that she fundamentally understands the value of empowering delegates and members.

Many of the delegates who Mary-Anne trained are still active today, and have changed their lives through applying the skills that she taught them.

One of the reasons that delegates maintained their activism was to do with the way the Mary-Anne trained them. Her training was always captivating and she took delegates on the journey that had them being as excited about being involved with the union because she herself was committed and was passionate about the union. Mary-Anne was often heard to say that she spent her day's tap dancing – If only everyone's tap dancing inspired delegates and members as much as Mary-Anne's.

Mary-Anne was also committed to OH&S. She was passionate about ensuring workers safety and she translated this to all her training courses.

Her commitment to our members has never waivered and now post Politics she continues her support in attending rallies and continuing to use her contacts to assist members wherever possible.

It is with great pleasure that our Branch recommends Mary-Anne for Life Membership of the ASU.





4.0 LIFE MEMBERSHIP — LINDEN SCOTTS

Linden Scotts received Life Membership of the United Services' Branch of the ASU at our Federal Conference in September 2011. The previous year Linden was awarded a Certificate of Merit at the Branch's 2010 Conference and it is only fitting that he now receives the highest acknowledgement for his outstanding services to the Union, Life Membership of the ASU.

Linden joined the Federated Clerks Union in 1970 while working at Tooth & Company then moved on to Adstream IXL and finally Carlton and United Breweries. He remained until 1997 when he accepted redundancy. During his employment at Carlton and United Breweries he took on the responsibility of Union Rep for two years. In 1999 Linden became a Union Rep at the Teachers Federation Health and has continued in this capacity until his retirement in December 2010.

From 2003 to 2010 Linden became a member of the Sydney C&A Branch Committee of Management. Linden accepted the position of Branch President and held this position until his retirement in 2010.

Linden has always carried out his duties in a highly professional and a gentlemanly way. He has been the key to the growth in our numbers and the enthusiasm of our Committee of Management members. Linden has always been honest, reliable and is highly regarded by his fellow delegates.





4.0 LIFE MEMBERSHIP – KEITH HARVEY

Nominated by: Victorian Private Sector Branch

Until June 30th 2011 Keith was employed full-time as a National Industrial Officer with the Australian Services Union. He had been so employed since the ASU was created in 1993.

Prior to that date Keith was an employee of the National Office of the Federated Clerks Union of Australia. He was first employed by the FCU in 1979 as Research Officer after completing his Economics degree.

In his employment at the ASU, he coordinated the Union's involvement in the grueling award modernisation process during 2008 and 2009.

Keith had personal responsibility for a number of occupational areas and industries including the private sector clerical occupation which was a priority sector.

He appeared in all hearings relating to the Clerks Private Sector Award and also in relation to many other industries and sectors. He wrote or coordinated many of the submissions filed by the ASU in the course of the award modernisation proceedings.

Keith would have had the heaviest workload of any union or employer advocate through that period as the ASU lodged more written submissions that any other single organisation.

Keith was also involved in the preparation for the recent ASU's SACS Equal Remuneration Order (Equal Pay case) Application which was ultimately successful.

Earlier part of his work for the Federated Clerks Union involved the establishment of committees and bodies to determine the need for and define the competency standards for the performance of clerical and administrative work which had never been done before.





4.0 LIFE MEMBERSHIP – KEITH HARVEY

In the late 1980s and early 1990s there was a concerted policy program undertaken by the then federal government in the areas of micro-economic reform and reform of the systems of vocational education and training. Keith was involved in this work such as being a member of the Employment and Skills Formation Council, a subsidiary body of the National Board of Employment Education and Training. The ESFC, while Keith was a member, produced a report advocating a new Vocational Training system in Australia which would include non-trades occupations, including clerical and administrative employees.

At the same time the government in concert with the ACTU and its affiliated trade unions and employer organisations began a process known as award re-structuring operating under the 'structural efficiency' principle of the then Commission.

This activity was undertaken in respect of clerical awards, beginning with the Victoria Commercial Clerks Award. Keith Harvey was part of the joint union-employer working party established to design and validate a new classification structure for the award. As a result of the working party's efforts a comprehensive skills based classification structure was introduced into the award.

Since his retirement he has been employed casually to perform industrial work for the ASU and two other unions.

Keith is also a Board member and Chair of Aspire Learning, a learning resources company publishing learning resources particularly for training employees in clerical and administrative occupations.

Until recently Keith was also a Board member of the Innovation and Business Skills Australia Industry Skills Council - responsible for the setting of training standards for occupations in the business services sector and in other industries.

Keith has also drafted several ASU submissions in relation to a wide range of Federal Government Inquiries into Workplace Relations related issues.

Keith has also trained other advocates and written academic papers on union and Labor history.

Keith's research and advocacy skills before industrial tribunals are highly regarded and the reason why he is still in demand after retirement; and not just by the ASU.





4.0 LIFE MEMBERSHIP — PAUL SLAPE

Paul retired from the union movement in 2011, after 46 years of service, most recently as the National Secretary of the Australian Services Union, a role he occupied for 14 years.

During his long career Paul worked at all levels of the organisation which gave him a sensitivity to and appreciation of the efforts of all of us working in the team to defend and advance workers' rights. This ensured he was not only respected by his colleagues but well loved, too.

As a leader of the MEU Victorian Branch, Paul also was a member of the VTHC Executive in the 1970s and 1980s and was also a member of the ACTU Executive from 1988 until his retirement.

Paul commenced with the Municipal Employees' Union (MEU) as a 17yr old administrative assistant in 1964, working as an Organiser from 1969-1976 until he was elected Assistant Secretary in 1976. Paul was elected General Secretary in 1982 and served in this position until 1993. In this same period, Paul was the Federal Secretary of the Union, becoming the Joint National Secretary of ASU from 1993 to 1996. Paul was elected National Secretary in 1997 until his retirement in March 2011.

Paul also recognised the need to guarantee workers' future prosperity after their retirements. To ensure the best possible outcomes he became part of the Local Authorities Superannuation Board or LASB (now known as Vision), and he served as a Director and President at various times.

Recognising the need for political activism to achieve real gains, Paul was also active in the ALP, serving a term as Victorian President.

His efforts for local government workers in particular extended to work on various other bodies including the ALGT (Australian Local Government Training), National Local Government Productivity Council, Victorian Grants Commission and the Australian Council of Local Government Steering Committee. His work on all these bodies was focussed on ensuring the best outcomes for workers.

Paul was also active on the international stage representing workers' interests. He held the positions of Chair Oceania Region and Executive Board Member for Public Services International (PSI) over many years. He used his position to promote international solidarity and he believed that promoting labour standards all over the world would lead to better outcomes for both overseas and Australian workers.

Barry O'Brien retired from his full-time position of ASU National Industrial Officer on Friday, 27th January 2012, at the age of three score and ten (70).

Barry worked with the ASU National Office for 27 years, commencing work as a National Industrial Officer with the Municipal Officers Association (MOA) on 3rd January 1985. His working history is best summarized in his own words from the following email message that Barry circulated to all of his friends and colleagues on 27th January 2012:

"Up until 1968 I had never been a member of a union and I had no real knowledge of Unions. If anyone had told me then that I would have been active and employed in the union movement for the next 44 years my life I would have told them they were insane.

My initiation into the union movement came about in 1967 due to circumstances which I found myself in whilst working as an offshore oilfield diver in Bass Strait. The classic reasons for unionism - unsafe working conditions, poor pay and conditions of employment, led me into become actively involved with the formation and registration of the a union called the Professional Divers Association of Australasia (the PDAA).

My involvement with the PDAA was from 1967 until 1991 when the PDAA amalgamated with the Seamen's Union. I believe it is a very real honour to have served the trade union movement for 45 years of my life. I am most grateful to the ASU for my last 27 years employment and most thankful to the officers and staff (past and present) who have been not only been my workmates but have become good friends.

I would like to acknowledge and pay tribute to all of my workmates and I feel proud to have been a member of past teams in the National Office and the present team.

I have greatly enjoyed working with each and every one of you and I know I will greatly miss the daily contact and social interaction at work with you all after I retire. He was the architect and driving force behind the very successful ASU National Energy Industry Committee that operated most effectively between 1995 and 2006. Barry provided terrific leadership and ensured that only the most principled decisions resulted from this professional working group of industrial officers and members that consistently rose above the usual petty bickering and politics that was the norm between branches, states and tribes.

Barry also played a very significant role in the substantial body of work required to achieve the reactivation and restructuring of our State Union s between 2009 and 2011.

Special mention must be made of his dedication, persistence and tenacity in ensuring that National David Taylor Memorial Award was adopted and delivered on behalf of ASU in the various States of Australia.
