Australian Services Union NATIONAL OFFICE

The ASU National Office complements the work of ASU Branches with involvement in many key Union activities including industrial work and tribunal appearances, enterprise bargaining, national campaigning, communications and lobbying.

The National Office employs a number of highly experienced and skilled specialists who are able to assist Branches with projects including complex award and agreement matters and union rules matters. An understanding of historical precedents, our agreements with other unions and tribunal decisions means we are well placed to offer advice.

We also have specialists in research, policy, communications, national purchasing and other areas.

The National Office is an integral part of the ASU which is a ready resource to assist the Union's Branches in representing the interests of our members.

Bargaining

Bargaining with national employers is often coordinated and/or led by the National Office. We are also able to provide assistance to Branches undertaking state-based bargaining. We have prepared resource materials on bargaining to assist Branches which are available via our website.

Award maintenance

The National Office was intensely involved in the award modernisation process, making submissions in over 100 matters. As a result we are extremely familiar with the new awards and are well placed to maintain them in the future - we coordinate the ASU's approach to the Modern Award Reviews. We also have access to an extensive history of award matters which can greatly assist in research for future cases.

Rules matters

Forming the backbone of our right to cover our members, union rules can be daunting in their complexity and fraught with difficulties to amend. Rule changes by other unions can also affect ASU coverage. National Officers are intimately familiar with the ASU rules and have ensured our interests are protected during rule changes. We monitor rule changing activities by other unions to ensure there are no negative impacts for the ASU. We can also assist Branches with their rules.

Campaigning & lobbying

Our Growth & Campaigns Team coordinates both industrial and political campaigns for the ASU. With the advent of professional lobbyists and lobbying companies, unions have had to become more sophisticated in their lobbying techniques. The Team is well versed in lobbying, particularly at the national level, having existing relationships with politicians and an understanding of how to arrange meetings with them on the issues we want to influence.

Legal

In house expertise means the National Office is in a position to offer valuable legal opinions on a range of union work. We have lawyers with current practising certificates amongst our industrial staff. We are experienced in acting as instructing solicitors to brief barristers for major cases.

National representation

Many consultative groups are set up nationally, requiring information to be distributed broadly and groups to be briefed. National Officers serve on these groups, including Industry Reference Committees (eg. GSA, IBSA Aspire, etc), ACTU committees (eg. Women, OHS, Indigenous, etc), etc, on behalf of our Branches to ensure everyone is kept in the loop.

Communications

The National Office is well positioned to deliver information across the Union. Via the national website and our social media presence, we can disseminate news quickly and effectively, greatly adding to take up of campaign actions. We use these capablities for both national and Branch campaigns. We perform a media liaison function for the whole Union as National Office is often the first port of call and we coordinate internal info dissemination of media mentions, campaign asks, ACTU info, etc.

Research & submissions

We have access to a wide range of industrial resources that put the National Office in a position to do comprehensive research.

An increasing part of our work has been ensuring the voice of our members is heard in political forums including Senate Inquiries and Productivity Commission investigations. The National Office has produced numerous national submissions over the years and can assist Branches produce state focussed submissions also.

Network coordination

When ASU Branches want to work together on areas of common interest, National Officers are well placed to assist with coordination. Examples include GLAM, ASU OHS network, etc.

Training

The National Office provides Right of Entry training to allow for the award of certificates recognised by FWC for the issuing of entry permits. We have also provided training on union governance. Other training is available upon request.

International

The ASU is affiliated with three global unions, the PSI, UNI and ITF, as well as having associations with ITUC, the ILO and overseas unions covering similar members to our own. Our international links allow us to participate in international campaigns and to access international support for our own campaigns. It also means we have networks to pursue multinational employers.

Administration

The National Office is in a unique position to offer Branches coordinated purchasing power. This has delivered cheaper telecommunications for the ASU, better insurance deals and access to competitively priced merchandise via the ASUshop.
