Nominated by: Central & Southern Queensland C&A Branch

Kath joined the Union in 1993, first employed as a receptionist, working her way to becoming an accomplished industrial officer. In 2011 she was elected Secretary of the ASU Qld Services Branch and QSU, the first time these positions were held by a woman, and also elected ASU National Vice President. She was a member of the Queensland Council of Unions (QCU) Executive.

A committed advocate for working people, Kath was highly respected in the union movement by employers and governments, leaving many industrial legacies.

Her most notable role was in the historic Queensland Social and Community Services Pay Equity Case (2008) which confirmed Queensland SACS workers performed work which was undervalued because of gender and laid the essential groundwork for the Federal Pay Equity Case (2012).

Through her leadership, lobbying and negotiation skills, Kath was instrumental in obtaining guarantees from the Gillard Government to fund the pay equity increases.




Robert (Bob) Ball Nominated by: Queensland (Services & Northern Administrative) Branch

One of Bob's greatest achievements as President was overseeing the change to the Union's structure and operations in the late 1990s from a servicing model to an organising one.

His determination, participation, leadership and vision have been an influential force in showing us all what it takes to beat the opposition and grow stronger from campaigning.




Marion Fielke
